### Commissioner Check-in – SSA Commissioners and Guests

The Commissioners and guests shared their experiences working/living through this global pandemic. Some thoughts shared:

- University of Chicago focus on businesses, organizations, and communities.
   Thus far 3,000 meals have been distributed and the level of food insecurity in the neighborhoods is a problem. A total of 182 relief funds to businesses, 48 in Hyde Park in the amount of \$165,000, have been granted. Community Programs Accelerator continues to support nonprofits (\$400,000).
- George Rumsey has assisted in the submission of 17 grants for teen moms due to lack of resources within a 3-week cycle.
- Mary Rogel expressed concern for the challenges small business such as herself whom have fallen through the cracks in relation to the Payroll Protection Program application process.

## Finance Committee/FY20 Budget Reallocation

The reallocation will be presented by the Finance Committee circulated to the Commissioners and submitted to the city. The amount of \$24,500 will be redirected to other services. The Finance Committee will share the preliminary decision on the redeployment of funds timeline within 2 weeks.

- 1. Do we know the number of businesses that have closed? (S. Newsome)

- 3. Can we not spend the funds and save for next year's budget? (G. Guttman)
- 4. Reallocated funds will support which businesses? (G. Guttman)
- 5. A business survey should be conducted to assess which businesses within the district need assistance, specifically those that may not have received any financial support (PPP, etc)

# Farmers Market Update – B. Evans and D. Burnham

A motion was made to postpone the 2020 market and move to 2021. The motion was moved (M. Rogel) and properly seconded (C. Newsome) and carried with no objections and assumed consensus.

Regarding the location of the market, Commissioner Marks had no updated information regarding the Harper Court construction with the current situation of the pandemic however will keep all abreast as information becomes available.

Brandon will notify the farmers and vendors of the market first through the enewsletter Constant Contact and then a public notification will be made.
